# PRELIMINARY INFORMATION

#### Subject: Appearance of Discoloration or Corrosion Near Edges/Openings on Chrome Bumpers

Models: 2010-2013 Chevrolet Express, Silverado 2010-2013 GMC Savana, Sierra Equipped with Chrome Bumpers

#### This bulletin is being revised to add the 2012 and 2013 model years. Please discard Pl0437.

The following diagnosis might be helpful if the vehicle exhibits the symptom(s) described in this PI.

#### **Condition/Concern**


Some customers may comment on what appears to be corrosion or a discoloration of the chrome surface near the edges or openings of the front and/or rear bumpers.

The cause of this condition may be that during processing, the supplier applies a protective paint to the backside of the bumper, and in some instances, the chrome surface was not adequately protected from paint overspray. This paint overspray may appear to be corrosion or a discoloration of the chrome.


#### **Recommendation/Instructions**

Inspect the affected chrome surface to determine whether the chrome only appears to be corroded or discolored from paint overspray, as opposed to the surface of the chrome actually being corroded. Examples of the overspray are shown below:





**Important::** Ensure the protective paint coating is not removed from the backside of any surfaces, including the raised edges of openings shown i the graphic below. Only remove the paint overspray from the visible surfaces.



Clean the affected surface to remove any residual overspray of the backside protective paint. Apply \*Kent Automotive Acrysol, P/N 20005, or \*3M General Purpose Adhesive Cleaner, P/N 08984, or equivalent, to a clean shop towel and wipe the affected chrome surface.

**Note:** Abrasives are not required to remove this overspray, so if the affected chrome surface cannot be cleaned using the referenced cleaners, the chrome may be affected by corrosion from another source.
