Front-end electronics control unit: If the vehicle key is not inserted completely into the ignition lock and the ignition lock is then turned to the position "Ignition on", the ignition lock will be locked after removing the key and the vehicle key can no longer be inserted into the ignition lock. Vehicles with Porsche Entry & Drive:

If the vehicle is locked using the locking button in the door handle, the key can be detected in some cases as being "inside the vehicle" if the vehicle key is too close to the vehicle. As a result, the key will be disabled for the next keyless access. The doors can then only be unlocked by pressing the Open button on the driver's key. To prevent this from happening, the front-end electronics control unit must be re-programmed with an Rear-end electronics control unit (only for model year 2012 vehicles): Due to a software error, there is a possibility that the rear-end electronics control unit will not switch to

energy-saving mode after the vehicle is stopped in the event of specific user behaviour. This can result in an increased closed-circuit current load and can thus cause the battery to become discharged.

To prevent this from happening, the rear-end electronics control unit must be re-programmed with an updated data record.

Action Re-program front-end electronics control unit. The rear-end electronics control unit is also re-programmed on model year 2012 vehicles. Required: Information The total time required for programming and coding is approx. 6-10 minutes. - Increased current draw during diagnosis or control unit programming can cause a drop in voltage, which can result in one or more fault entries and the abnormal termination of the programming process.


If complaints are received or if warning messages indicating a fault in the Porsche Stability Management (PSM) system are displayed, these faults must be located and corrected before carrying out control unit programming.

This work **cannot** be invoiced under the workshop campaign number.

Procedure:

 Having the fan on and the associated increased current draw can cause a drop in voltage, which can result in abnormal termination of control unit programming.

- 2 Connect a battery charger with a current rating of **at least 40 A** to the jump-start terminals in the engine compartment.
- 3 Switch on the ignition using the **original vehicle key**. On vehicles with "Porsche Entry & Drive", do this by replacing the control panel in the ignition lock with the original vehicle key if necessary.
- 4 Move the windshield wiper lever to position 0 (= windshield wipers off) to prevent the windshield wipers from coming on during programming.
- 5 **9818 PIWIS Tester II** with test software version **10.900** (or higher) installed must be connected to the vehicle communication module (VCI) via the **USB cable**. Then, connect the communication module to the vehicle and switch on the PIWIS Tester.

Carrying out control unit programming

The procedure described here is based on the PIWIS Tester II software version **10.900**.

The PIWIS Tester instructions take precedence and in the event of a discrepancy, these are the instructions that must be followed. A discrepancy may arise with later software versions for example.

Important: CRITICAL WARNING #2: As of PIWIS Tester Software version 11.250, it is necessary to have the ignition on (with the original vehicle key) prior to connecting the PIWIS Tester II to the vehicle. Failure to turn on the ignition first may result in corruption of the Maintenance of Vehicle Data if programming or coding operations are carried out. In the event this occurs, the Maintenance of Vehicle Data must be reentered. You may reference the PPN posting on Maintenance of Vehicle Data for further information.

Procedure:

1 On the PIWIS Tester start screen, call up the \Rightarrow 'Diagnostics' menu and select vehicle type \Rightarrow 'Panamera'.

The diagnostic application is then started and the control unit selection screen is populated.

2 In the control unit selection screen (\Rightarrow 'Overview' menu), press • F7[#] to call up the \Rightarrow 'Additional menu' (\Rightarrow Control unit selection).

- 3 When the question "Create Vehicle Analysis Log (VAL)?" appears, either press F12" to create a VAL or press F11" if you do not want to create a VAL.
- 4 Press •>>" to acknowledge the message informing you that campaigns for the vehicle are stored in the PIWIS information system.
- 5 Select the ⇒ 'Campaign' function and press
 >> " to confirm your selection ⇒ Additional menu Campaign.

You are then prompted to enter a programming number.

7 Enter the programming number WC34_970 and press• Enter "to confirm.

The text box turns blue. Press $\bullet >>$ " to start the guided programming sequence.

Read and follow the **information and instructions on the PIWIS Tester** during the guided programming sequence. **Do not interrupt programming and coding. VEHICLE VOLTAGE MUST REMAIN BETWEEN 13.5 AND 14.5 VOLTS DURING THE ENTIRE WORK PROCEDURE.**

Programming and coding is performed in several steps:

- The gateway control unit is first re-coded in preparation for programming.
- Then, the **front-end electronics** control unit and for **model year 2012** vehicles, the **rear-end electronics** control unit is also re-**programmed** and then **automatically** re-**coded**.
- The gateway control unit is coded again once programming is complete.

The **display in the instrument cluster is switched off** while the front-end electronics control unit is being programmed and will remain off during the entire programming procedure. The message "Ignition key not removed" appears in the multi-function display.

The ignition is still active in the background.

Never switch the ignition off and then on again because if you do, programming will be interrupted and will then have to be restarted.

The display in the instrument cluster will be switched on again automatically as soon as programming is complete.

The **Porsche part number** of the front-end electronics control unit and the rear-end electronics control unit if necessary, which can be read out in the \Rightarrow "Extended identification" menu using the PIWIS Tester, will not change following control unit programming.

The **software version** specified in the \Rightarrow "Extended identification" menu is decisive for checking whether the control unit software is up-to-date.

If programming does not start, the campaign number must be entered again and programming must be restarted.

If an **error message** is displayed after starting programming (e.g. "Campaign does not exist", "No suitable programming rules found" or "Vehicle data could not be read", etc.), follow the appropriate instructions provided under \Rightarrow *Technical Information 'WC3400 Troubleshooting'*.

If **programming is interrupted** (e.g. due to a voltage drop or if communication is aborted, etc.) or if **programming could not be carried out successfully** (error message "Programming unsuccessful"), follow the **instructions provided under** \Rightarrow *Technical Information 'WC3400 Procedure after programming is aborted* 'to repeat the programming procedure.

It is **not** possible to program the control units manually.

If one or more control units are not coded successfully (Step 10 of the guided programming sequence) once control unit programming is complete, the affected control units must be **re-coded** again separately once the guided programming sequence is complete.

To do this, select the control unit or control units for which coding could not previously be carried out successfully in the control unit selection screen ("Overview" menu) and press •>>" to confirm your selection. Once the control unit or control units have been found, select the **"Codings/adaptations"** menu and re-code the control unit or control units using the **"Automatic coding"** function.

Once programming is completed successfully (message "Campaign was carried out successfully"), carry out the **Subsequent work** described below.

If the fault memories of individual control units cannot be erased, start the engine briefly and then switch the ignition off and then on again. Then erase the fault memories of these control units separately.

If control units are found to have faults which cannot be erased and are not caused by control unit programming, these faults must be located and corrected. This work **cannot** be invoiced under the workshop campaign number.

- 3 Disconnect the PIWIS Tester from the vehicle.
- 4 Switch off and disconnect the battery charger.
- 5 On vehicles with Porsche Entry & Drive, replace the original vehicle key in the ignition lock with the control panel again.
- 6 Enter the workshop campaign in the Warranty and Maintenance booklet.

Information If programming is aborted (the message "Programming was not completed successfully" is displayed on the PIWIS Tester screen), always proceed in accordance with the procedure described below.

Procedure:

- If the message "Programming was not completed successfully" is displayed, first press • F11" to cancel the programming procedure and then go back to the start page of the Additional menu.
- 2 Actuate the central locking button in the centre console to "wake up" the gateway control unit and re-establish communication between the gateway control unit and the front-end electronics control unit.



Information

There may be no response or reaction from the vehicle after pressing the central locking button. Nevertheless, internal communication between the gateway control unit and the front-end electronics control unit was re-established so that programming can now be carried out again.

- 3 Select the **>'Campaign'** function and try to **restart** control unit programming by **entering the** programming number again.
- If programming is completed successfully following the restart (message "Campaign was carried out successfully"), carry out the work described under \Rightarrow Technical Information 'WC3400 Subsequent work'.
- If programming is not completed successfully even after restarting (message "Programming was not completed successfully" is displayed again), Steps 1 to 3 must be repeated until programming is completed successfully. It may be necessary to restart programming up to three times in individual cases.
- If programming does not start again after entering the programming number or is not completed successfully even after restarting programming at least three times (message "Programming was not completed successfully"), carry out the following work:
- Press F11[#] to cancel programming. 4
- 5 Switch off ignition.
- 6 Pull fuses for the front-end electronics control unit out of the slot in order to reset the control unit. Then re-insert the fuses.
 - Left-hand drive vehicles: Fuse box on left of dashboard, fuses No. 23 (30 A), No. 24 (30 A), No. 25 (15 A) and No. 26 (30 A)

Right-hand drive vehicles: Fuse box on right of dashboard, fuses No. 33 (30 A), No. 34 (30 A), No. 35 (15 A) and No. 36 (30 A)

For model year 2012 (C) vehicles, also remove the fuses for the rear-end electronics control unit (fuse and relay carrier in luggage compartment, fuses No. 1 (15 A), No. 2 (15 A), No. 3 (30 A) and No. 4 (30 A)) from the slot and then re-insert them.

After re-inserting the fuses, there is a possibility that the ignition cannot be switched on and the instrument cluster will remain off.

However, the driver's key in the ignition lock must still be turned to "Ignition on" position. Communication between the vehicle and PIWIS Tester can then be re-established despite the fact that the ignition and instrument cluster appear to be switched off.

- 7 Switch on ignition and restore communication between the vehicle and the PIWIS Tester.
