Models: 2012 and 2013 Chevrolet Express, Silverado

2012 and 2013 GMC Savana, Sierra Equipped with the 6.6L Duramax Diesel Engine RPO codes LGH and LML With or Without DTC P0606

The following diagnosis might be helpful if the vehicle exhibits the symptom(s) described in this PI.

As part of our ongoing quality improvement efforts the 2012 and 2013 6.6L Duramax Diesel Engine Control Module Part numbers 12648344 and 12654088 will be placed on a parts restriction through the Product Quality Center (PQC). This parts restriction will assist Engineering with product feedback.

Please follow this diagnostic or repair process thoroughly and complete each step. If the condition exhibited is resolved without completing every step, the remaining steps do not need to be performed.
