WARRANTY CONDITIONS MODIFICATION

The current fuel tank warranty will be exceptionally extended to 10 years - including parts and labor - from the date that the vehicle was first put in service. This warranty extension applies exclusively to the vehicles listed in this document and the following conditions apply:

- 1st failure: fuel tank must be repaired
- 2nd failure: fuel tank must be replaced

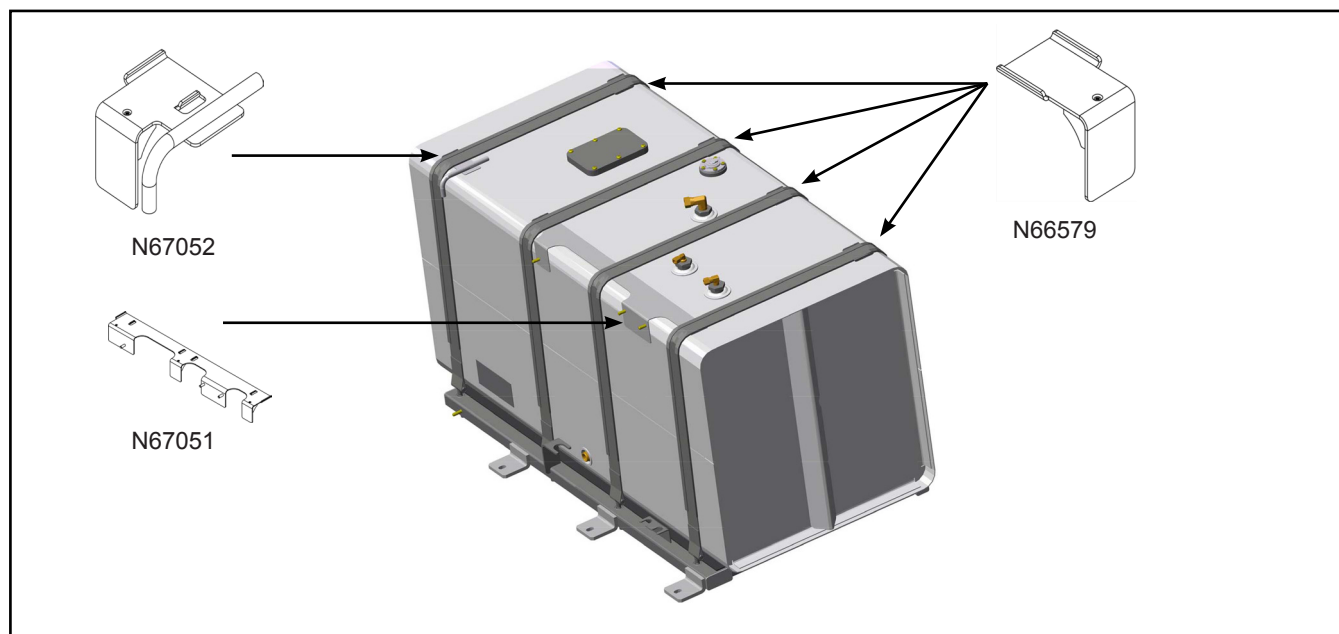


Figure 1 - Fuel Tank

In the case of the fuel tank replacement, N67051 stud plate, the corner supports N67052 and N66579 should be installed under the fuel tank straps. See Figure 1 and the Nova Bus maintenance manual for the replacement procedure.❖
