Subject: Transmission Fluid Leak at Auxiliary Pump Seal


Models: 2014 Chevrolet Malibu

Equipped with 6T40 Automatic Transmission (RPO MNH)

This PI has been revised to add the two Important statements. Please discard PI1071.

Condition/Concern

Some customers may comment on a transmission leak.



Investigation of the leak may show that the fluid is leaking on top of the transmission at the auxiliary fluid pump seal (6).

Recommendation/Instructions

If leak diagnosis determines that the leak source is the auxiliary fluid pump seal, it should be replaced.

Important: To prevent damage to the replacement seal, be sure to lubricate the seal with transmission fluid before installing the auxiliary pump.

For replacement of the seal, refer to the Auxiliary Fluid Pump Replacement procedure in SI.

Important: The auxiliary pump seal should be checked for leaks after installation using the following steps.

- 1. Start the engine.
- 2. With the transmission in Park and the park brake applied, raise the engine speed to 4,000 RPM for at least 30 seconds.
- 3. After 30 seconds, shut off the engine and inspect the transmission for leaks in the area of the auxiliary pump.
