Condition

Technical Background

Engine control module (ECM) adaptation is required before vehicle delivery.

Production Solution

Not applicable.

Service

Perform ECM adaption during pre-delivery inspection by completing the following steps.



Tip: This process works best with VAS PC and VSD on the scan tool.

- 1. Check and clear the DTCs in the ECM master, J623 (address word 01), three times within 20 seconds. Go to On Board Diagnostics (OBD) >> (01) Engine electronics >> 004 DTC memory content >>004.01 - Check DTC memory >> 004.10 - Erase DTC memory.
- 2. Check and clear the DTCs in the ECM slave, J624 (address word 11), three times within 20 seconds. Go to On Board Diagnostics (OBD) >> (11) Engine electronics 2 >> 004 DTC memory content >>004.01 - Check DTC memory >> 004.10 - Erase DTC memory.
- 3. After checking and clearing both the ECM master (01) and the ECM slave (11) three times, hit the on-screen refresh button. The button will turn green after refresh.
- 4. Cold start the vehicle with the coolant temperature between 20°C and 25°C.
- 5. Let the vehicle high idle in "P" gear without touching the accelerator pedal until the car heating/secondary air phase is over (idle returns to normal speed below 1,000 RPM).
