Condition

Customer complaint:

• Audi Lane Change Assistant deactivates or is sporadically inoperative

Workshop Findings:

- Audi Lane Change Assistant can be activated without issue
- One or both of the following DTCs is stored in the Lane Change Assistance control module J769 (3C):
 - DTC 02853 (Lane Change Assistance Warning Lamp -K233- Open/Short Circuit to B+)
 - DTC 02854 (Lane Change Assistance Warning Lamp -K234- Open/Short Circuit to B+)

Technical Background

A software issue within J769 causes a diagnostic fault, which deactivates the Audi Lane Change Assistant temporarily.




Figure 1. Related Sites section on Accessaudi.com landing page

- Create a PSS record in the PSS application via the hyperlink in Accessaudi.com (Figure 1) or Technical Assistance page in Elsa (Figure 2).
