NOTE: This bulletin applies to vehicles built on or after June 10, 2013 (MDH 0610XX) on or before July 05, 2013 (MDH 0705XX) equipped with Front Passenger Seat Belt Alert (sales code LAX).

## SYMPTOM/CONDITION:

The customer may experience that there is no audible sound indicating that the right front seat belt reminder is functioning.

#### DIAGNOSIS:

Using a Scan Tool (wiTECH™) with the appropriate Diagnostic Procedures available in TechCONNECT, verify no DTC's are set. If DTC's are present record them on the repair order and repair as necessary before proceeding further with this bulletin.

If a customer's VIN is listed in VIP or your RRT VIN list, perform the repair. For all other customers that describe the symptom/condition, perform the Repair Procedure.

### REPAIR PROCEDURE:

- 1. Using wiTECH, reconfigure the vehicle. This routine is available under the 'Diagnostic Procedures' tab found on the home, 'Vehicle View', page of wiTECH.
- 2. Using wiTECH clear any DTCs which may have been set during the reconfiguration.
