STOP DELIVERY ORDER

This stop delivery was original sent to dealers on January 28, 2013. The population for this stop delivery has been expanded to include an additional 16 U.S. vehicles. These additional vehicles are identified on the attached VIN list.

Effective immediately, stop the delivery of certain 2013 model year Chevrolet Sonic RS vehicles, equipped with manual transmissions due to a window sticker issue. The attached revised list provides the Vehicle Identification Number (VIN) of each involved vehicle. It is sorted by dealer Business Associate Code (BAC) for easy reference. If your dealership's BAC is not listed, then none of the involved vehicles are currently assigned to you and no further action is required.

The vehicles that are identified on the attached list that are in dealer inventory must be held and not delivered to customers, dealer traded, or used for demonstration purposes until a corrected window sticker is installed on the vehicle.

Corrected window stickers were mailed to dealers for the vehicles on the original list on January 29, 2013. Corrected window stickers for the additional 16 vehicles are being mailed to dealers on February 12, 2013.

After the correct window sticker has been applied to the vehicle, the stop delivery order is satisfied and the vehicle is available for sale.

All other 2013 model year Chevrolet Sonic vehicles in dealer inventory that are not on the involved VIN list are not restricted from sale or delivery.
