IMPORTANT SAFETY RECALL

Re: Transmission Recall Notice

Dear 2013 COPO Camaro Purchaser:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

ATI Performance Products Incorporated ("ATI") has advised General Motors Company that a potential defect which relates to motor vehicle safety exists in certain Powerglide transmissions which have been installed in 2013 COPO Camaro off road race vehicles delivered during calendar year 2013. While there have been no reports of customers having malfunctions with these transmissions, a park test which is performed prior to release of the COPO Camaro revealed that, in some instances, there is a non-positive park engagement. This may result in a car moving while the park position is engaged. This may result in potential risk of bodily harm or property damage. Additionally, this defect does not apply to any COPO Camaro vehicles delivered prior to January 1, 2013.

Our records indicate that you were delivered a COPO Camaro from General Motors Company after January 1, 2013 and that it may or may not have a transmission with a non-positive park engagement. If your transmission has this problem, it may be replaced at no cost to you.

ATI is conducting a safety recall of Powerglide transmission in the 2013 COPO Camaro off road race vehicles.

There is a simple test to determine if your transmission has a non-positive park engagement. It is suggested that this test be performed as soon as possible and that until this test is performed your vehicle be secured from rolling forward or backward. This is easily accomplished by placing wheel chucks both behind and in front of the rear wheels. If your car is kept on a steep incline, it is suggested that it be moved to flat ground and properly secured.

If your vehicle passes the inspection, no further action will be required. If your vehicle does not pass this test, your transmission and torque converter will be exchanged at no charge. Any action necessary will be discussed at the time of your phone call to ATI.
