Subject: 2013-2014 Cadillac ATS Manual Transmission Exchange

Models: 2013-2014 Cadillac ATS
Equipped with manual transmission RPO M3L

This PI was superseded to update model years. Please discard PIP5070.

The following diagnosis might be helpful if the vehicle exhibits the symptom(s) described in this PI.

Condition/Concern

GM Product teams continually seek valuable information for engineering improvements.

To assist in this effort, the 2013 Cadillac ATS 6 Speed Manual Transmission Exchange program will be administered by the GM Product Quality Center (PQC). Dealerships are required to call the PQC, not GM Technical Assistance (TAC), to request an exchange.

PQC may refer the dealer technician to TAC if additional diagnosis is required. TAC will be available for product inquiries that do not require assembly replacement.

Recommendation/Instructions

The Tremec 6 speed manual transmission (TR3160) used in this vehicle is currently not internally serviceable and must be replaced as an assembly.

DO NOT disassemble the unit to determine root cause or point of failure. See the following document and item numbers in service information for a list of serviceable items.
