- Only vehicles with Concert Radio (PR 8UQ) and standard sound system (PR 9VD) are affected.

- 1. Check for and clear stored DTCs in the amplifier (digital sound system control module, J525 (47)).
- 2. Perform an SVM specified/actual comparison.
- 3. Disconnect scan tool, turn ignition off, lock vehicle and wait for communication bus to fall asleep.
- 4. Attempt to duplicate customer's original concern.
- If the issue is still present, contact the Technical Assistance Center for further troubleshooting assistance. Attach the GFF scan and specified/actual comparison.
- 6. Before releasing vehicle, verify that there are no DTCs stored in the amplifier.
- 7. Explain to customer that the measures taken are only a temporary repair and a new solution will be released. Replacing audio system related components will not cure the issue.
