SERVICE BULLETIN

REASON FOR RELEASE: Modification to mitigate the potential sticking of the Truck Duck diesel powered hand throttle cable and foot pedal.

Urgency:

It is recommended this modification take place immediately.

General:

This modification consists of a simple enlargement of an existing drill hole in which the hand throttle cable runs through. This cable is tied to the foot throttle pedal. See Figure on (page 2)

Directions:

1. Locate the hand throttle cable within the engine bay near the low portion of the fire wall and connected to the foot throttle pedal arm.
2. Remove the linkage from the foot pedal arm and enlarge the drill hole that the cable runs through (drill out ¼" diameter)
3. When reinstalling and tightening the drilled linkage to foot pedal arm, ensure the linkage will swivel with the rotation of the foot pedal arm.

Note: The results of this modification allows the cable to freely maneuver through the linkage hole without sticking.

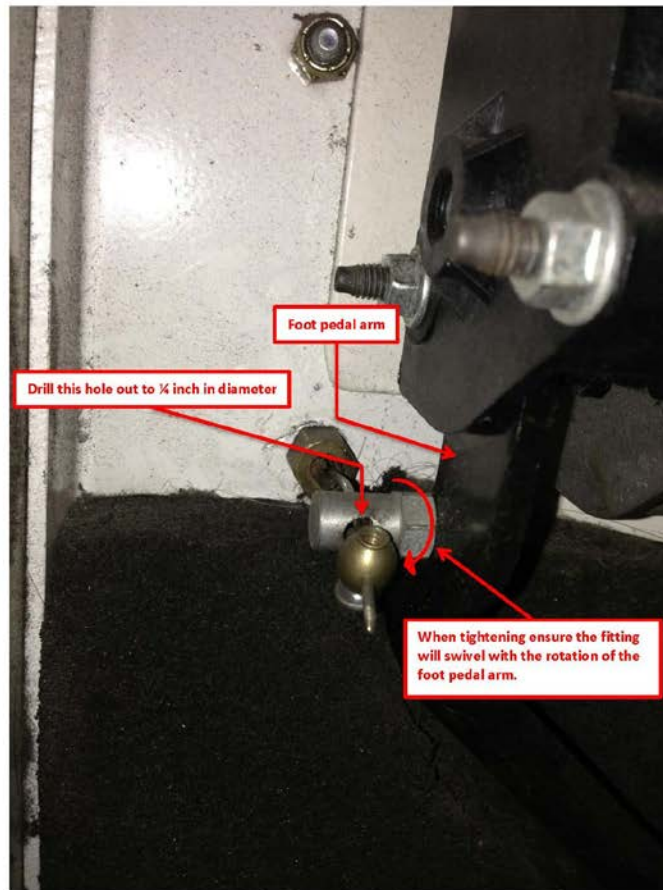
