STOP DELIVERY ORDER

On October 1, 2014, GM issued a stop delivery order involving certain 2013-2014 model year Cadillac CTS, Escalade, and Escalade ESV; Chevrolet Captiva, Suburban and Tahoe vehicles; and GMC Yukon and Yukon XL vehicles and certain 2014 model year Buick Enclave; Chevrolet Express, Impala, Silverado HD and Traverse; and GMC Acadia, Savana and Sierra HD vehicles. These vehicles were built with a chassis electronic module suspected of containing internal contamination. See GlobalConnect Message # G_0000201459.

Approximately 8,776 additional vehicles have been added to the recall population. These vehicles were serviced with a chassis electronic module suspected of containing internal contamination. A very small number of older model vehicles are now included so you may find certain 2003-2011 model year vehicles such as Chevrolet Trailblazer, Colorado, Sierra, Silverado, Suburban, Tahoe, Avalanche and Equinox; GMC Terrain, Sierra, Yukon, and Canyon; HUMMER H2 and H3; Saturn VUE, and Outlook models identified in IVH which

has been updated as of today December 2, 2014. Additionally, the IVH system issue that was communicated yesterday has been rectified and all involved vehicles should now show "Incomplete – Remedy Not Yet Available".

Attached is a list that provides the VIN of 11 vehicles that were added to this population which our records indicate are in dealer stock.

Until further instructions are received, these vehicles must be held and not delivered to customers, dealer traded, released to auction, or used for demonstration purposes.

Instructions for releasing the involved vehicles from this stop delivery will be provided in the near future.
