Subject: BAS+ (HYBRID) eAssist TAC Parts Restriction

All equipped with eAssist (RPO HP6)

This PI was superseded to update parts and warranty information. Please discard PIP4920L.

The following diagnosis might be helpful if the vehicle exhibits the symptom(s) described in this PI.

Condition/Concern

As part of our ongoing quality improvement process, the following components will remain on restriction through the GM Technical Assistance Center (TAC).

Note: The Starter Generator (MGU) and Auxiliary Pump have been removed from parts restriction through the Product Quality Center (PQC) or the GM Technical Assistance Center (TAC).

Recommendation/Instructions

Important: If the 12V system voltage has fallen below a predetermined level (approximately 9V), use GDS2 to command the Battery Pack Cooling Fan on to make sure it operates.

- If the Battery Pack Blower Fan is inoperative and the vehicle build date is on or between December 15, 2011 and April 23, 2012, replace the Battery Pack Cooling Fan.
- Check to ensure the Generator Control Module SPS calibrations are current.
- If the vehicle build date is before December 15, 2011 or April 23, 2012 and later, follow published G.S.I. Diagnostics.

Note: Prior to performing any SPS Programming or Clearing DTCs, save the DTC Freeze Frame / Failure Records using GDS2.

Important: After a Powerpack, GCM or BECM is replaced, the BECM and/or GCM will need to be programmed using the Techline Information System (TIS) / Service Programming System (SPS). Verify the correct part number is installed prior to performing SPS programming.
