Condition

The shifting operation of the gearbox may feel uncomfortable when the vehicle is coming to a stop, or slight engine hesitation may be felt when taking off from a stop.

Technical Background

Incorrect calibration of the engine control module (ECM) and transmission control module (TCM) software.

Production Solution

New software in the ECM and TCM addressed the condition.

Service

Verify that the *Condition* and *Technical Background* match exactly before proceeding. If other conditions exist or if faults are present, this bulletin will not work and should not be followed.

SVM Update Instructions

- 1. Follow all instructions in TSB 2011732: 00 Software Version Management (SVM), operating instructions.
- 2. Update the ECM (J623) and TCM (J217) using the SVM action code as listed in the table below, if necessary.
- 3. Perform road test to confirm repair.
