REMINDER

This is not a new recall. This is a reminder that a recall notice sent out in March 2013 for your vehicle has not been addressed.

IMPORTANT SAFETY RECALL NOTICE

Dear Owner of STOUGHTON Brand Grain Hauler Trailer:

Last year you received a notice of a recall for the trailer you own that is listed above. Our records show that you have not yet brought your trailer in for the corrective repairs. At your earliest convenience please bring your trailer to one of the authorized repair shops so that the repairs can be completed.

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Stoughton Trailers, LLC (Stoughton) has decided that defect(s) which may relate to motor vehicle safety exist(s) in model year 2009 – 2011 STOUGHTON brand AHV model trailers (commonly referred to as “Grain Haulers” or “Ag Hoppers”).

- **You should contact your nearest participating dealer or authorized repair shop to arrange for corrective repairs.**

The defects include one or both of the following:

- A. Possible fatigue cracks found in the suspension subframe channels to hopper crossmember front attachment. While Stoughton is unaware of any instance in which a crack in the suspension subframe front attachment has led to a loss of vehicle control or a crash, if such crack(s) develops and is left uncorrected, Stoughton is not able to rule out the possibility that over the life of the trailer, crack(s) in the suspension subframe front attachments could lead to loss of vehicle control and/or a crash which could result in serious bodily injury or death, as well as property damage.
- B. Possible fatigue cracks in the lower rails in the area just forward of the landing gear of the trailer. Stoughton is not aware of any instances in which the lower rail has completely fractured, or of any instances in which cracking of the lower rail in this area has lead to a loss of vehicle control or a crash. However, Stoughton is not able to rule out the possibility that over the life of the trailer, cracks developing in the lower rail that are not repaired could lead to a failure of the rail at some point. Such a failure could result in serious bodily injury or death, as well as property damage.

The remedies for these issues are as follows. Stoughton will replace the front attachment of the suspension subframe on all trailers covered by this recall. This will be performed according to Stoughton repair document RD-00040. Stoughton will also replace the structure inside the lower rail in the area just forward of the front hopper if it was produced with an aluminum crossmember next to the hopper. This will be performed according to Stoughton repair document RD-00031.

These upgrades will be provided at no charge to the trailer owners when performed at a participating dealer or authorized repair shop. It will take one to two days to complete the work. Attached is a list of participating dealers and authorized repair shops. Please contact one of them to schedule an appointment to have the work done.

If you no longer own this grain trailer, please contact Stoughton to provide the new owner information. Stoughton will then contact the new owner.

If you are the lessor of this vehicle, please forward a copy of this notice to the lessee within 10 days to comply with federal regulations.

If you have already paid to have your grain trailer repaired to correct the aforementioned conditions, you may be eligible for reimbursement of the charges you paid for that repair.
