# Condition

This Update has been proactively released to prevent the following condition from occurring in the vehicle:

MIL on for random cylinder misfires during cold start.

This Update is in effect until removed.

Vehicle must meet all of the following criteria:

- Procedure is valid only for vehicles that show the 24AL code in the Elsa Campaign/Action Information screen on the day of repair.
- Vehicle must be within the FEDERAL EMISSIONS warranty.
- Procedure must be performed within the allotted time frame stated in this Technical Service Bulletin.
- Procedure must be performed on applicable vehicles in dealer inventory prior to sale.

## **Technical Background**

The MIL may illuminate for random cylinder misfire if the coolant temperature is between 18° and 36°C.
