Safety Recall: Power Steering Hose Attenuator Collapse

CONDITION SUMMARY:

Situation: A concern has been identified on a number of 2013-2014 model year Jaguar XF (X250; XFR-S variant only) where vehicles being driven aggressively with frequent high energy steering inputs, the Power Steering hose attenuator at the steering rack end may collapse and cause a restriction in the hose. This restriction of power steering fluid flow can cause loss of the steering power assistance and loss of power steering fluid. The mechanical steering link to the steering wheel and road wheels is maintained at all times.

Action: Retailers are required to HOLD all affected vehicles that are within your control and refrain from releasing the vehicles for new or used vehicle sale pending completion of the rework action detailed in this Technical Bulletin. Unsold vehicles should have this performed as part of the Pre-Delivery Inspection (PDI) process but must have it completed prior to vehicle handover to the customer. Affected vehicles already in the hands of customers should be updated at the next available opportunity.

Warranty claims must be submitted for payment within 30 calendar days of completion of the repair.
