CUSTOMER SATISFACTION PROGRAM

Low Engine Coolant Level without an External Leak SUBJECT:

MODELS: 2011-2014 Chevrolet Cruze

With 1.4L Engine (RPO LUJ or LUV)

All involved vehicles that are in dealer inventory must be held and not delivered to customers, dealer traded, or used for demonstration purposes until the repair contained in this bulletin has been performed on the vehicle.

THIS PROGRAM IS IN EFFECT UNTIL AUGUST 12, 2016.

CONDITION

Certain 2011-2014 model year Chevrolet Cruze vehicles equipped with the 1.4L engine (RPO LUJ or LUV) may have a condition in which a low engine coolant level may be observed in the coolant reservoir even though there are no external leaks present. Some customers may have noticed that the coolant level was full when the vehicle was new but the coolant level decreased over time. If air was trapped in the cooling system during the coolant fill process at the plant, the coolant level may have decreased over time as the trapped air was purged from the cooling system.

CORRECTION

Dealers are to inspect the cooling system level and fill it to the appropriate level if it is low.

VEHICLES INVOLVED

All involved vehicles are identified by Vehicle Identification Number on the Investigate Vehicle History screen in GM Global Warranty Management system. Dealership service personnel should always check this site to confirm vehicle involvement prior to beginning any required inspections and/or repairs. It is important to routinely use this tool to verify eligibility because not all similar vehicles may be involved regardless of description or option content.

For dealers with involved vehicles, a listing with involved vehicles containing the complete vehicle identification number, customer name, and address information has been prepared and will be provided to US and Canadian dealers through the GM GlobalConnect Recall Reports, or sent directly to export dealers. Dealers will not have a report available if they have no involved vehicles currently assigned.

The listing may contain customer names and addresses obtained from Motor Vehicle Registration Records. The use of such motor vehicle registration data for any purpose other than follow-up necessary to complete this program is a violation of law in several states/provinces/countries. Accordingly, you are urged to limit the use of this report to the follow-up necessary to complete this program.


PART INFORMATION

Parts required to complete this program are to be obtained from General Motors Customer Care and Aftersales (GMCC&A). Please refer to your "involved vehicles listing" before ordering parts. Normal orders should be placed on a DRO = Daily Replenishment Order. In an emergency situation, parts should be ordered on a CSO = Customer Special Order.

SERVICE PROCEDURE

- 1. Open the hood.
- 2. Locate the coolant surge tank.

Warning: With a pressurized cooling system, the coolant temperature in the radiator can be considerably higher than the boiling point of the solution at atmospheric pressure. Removal of the surge tank cap, while the cooling system is hot and under high pressure, causes the solution to boil instantaneously with explosive force. This will cause the solution to spew out over the engine, the fenders, and the person removing the cap. Serious bodily injury may result.

Note: Refer to Cooling System Draining and Filling in SI if required.

- 3. Determine the coolant level in the coolant surge tank.
 - If the coolant level in the surge tank is at the "COLD" mark (1) on the coolant surge tank, no further action is required.
 - If the coolant level in the surge tank is below the "COLD" mark (1) on the coolant surge tank, remove the surge tank cap when the cooling system, including the coolant surge tank pressure cap and upper radiator hose is no longer hot. Proceed to step 4.
- 4. Add a mixture of 50/50 DEX-COOL® antifreeze and clean drinkable water into the coolant surge tank until the coolant level reaches the "COLD" mark (1) on the coolant surge tank.
- 5. With the coolant surge tank pressure cap off, start the engine and let it run until the upper radiator hose can be felt getting hot. Watch out for the engine cooling fan. By this time, the coolant level inside the coolant surge tank may be lower. If the level is lower, add more of the proper DEX-COOL coolant mixture to the coolant surge tank until the level reaches the indicated level mark.
- 6. Turn the engine off and check the level in the coolant surge tank when the cooling system has cooled down.
 - If the coolant level **is not** at the "COLD" mark (1), repeat Steps 4–6.
 - If the coolant level <u>is</u> at the "COLD" mark (1), proceed to step 7.
- 7. Install the coolant surge tank cap.
- 8. Rinse away excess coolant from the engine and the engine compartment.

<u>COURTESY TRANSPORTATION</u> – For US and Canada

The General Motors Courtesy Transportation program is intended to minimize customer inconvenience when a vehicle requires a repair that is covered by the New Vehicle Limited Warranties. The availability of courtesy transportation to customers whose vehicles are within the warranty coverage period and involved in a product program is very important in maintaining customer satisfaction. Dealers are to ensure that these customers understand that shuttle service or some other form of courtesy transportation is available and will be provided at no charge. * The amount identified in "Net Item" should represent the actual sum total of the current GMCC&A dealer net price for the engine coolant needed to perform the required repairs, not to exceed \$10.00 USD, \$12.00 CAD, plus applicable Mark-Up or Landed Cost (for Export).

<u>CUSTOMER NOTIFICATION</u> – For US and Canada

General Motors will notify customers of this program on their vehicle (see copy of customer letter included with this bulletin).

CUSTOMER NOTIFICATION – For Export

Letters will be sent to known owners of record located within areas covered by the US National Traffic and Motor Vehicle Safety Act. For owners outside these areas, dealers should notify customers using the attached sample letter.

DEALER PROGRAM RESPONSIBILITY

All unsold new vehicles in dealers' possession and subject to this program <u>must</u> be held and inspected/repaired per the service procedure of this program bulletin <u>before</u> customers take possession of these vehicles.

Dealers are to service all vehicles subject to this program at no charge to customers, regardless of mileage, age of vehicle, or ownership, from this time forward.

Customers who have recently purchased vehicles sold from your vehicle inventory, and for which there is no customer information indicated on the involved vehicle listing, are to be contacted by the dealer. Arrangements are to be made to make the required correction according to the instructions contained in this bulletin. A copy of the customer letter is provided in this bulletin for your use in contacting customers. Program follow-up cards should not be used for this purpose, since the customer may not as yet have received the notification letter.

In summary, whenever a vehicle subject to this program enters your vehicle inventory, or is in your facility for service in the future, you must take the steps necessary to be sure the program correction has been made before selling or releasing the vehicle.

DEALER PROGRAM RESPONSIBILITY

All unsold new vehicles in dealers' possession and subject to this program <u>must</u> be held and inspected/repaired per the service procedure of this program bulletin <u>before</u> customers take possession of these vehicles.

Dealers are to service all vehicles subject to this program at no charge to customers, regardless of mileage, age of vehicle, or ownership, through August 12, 2016.

Customers who have recently purchased vehicles sold from your vehicle inventory, and for which there is no customer information indicated on the involved vehicle listing, are to be contacted by the dealer. Arrangements are to be made to make the required correction according to the instructions contained in this bulletin. A copy of the customer letter is provided in this bulletin for your use in contacting customers. Program follow-up cards should not be used for this purpose, since the customer may not as yet have received the notification letter.
