PRELIMINARY INFORMATION

Subject: Water Present on Front Passenger Floor, A/C Drain Hose Not Positioned Correctly

Models: 2014-2015 Cadillac ELR 2011-2015 Chevrolet Volt

Attention: This PI also applies to any of the above models that may be Europe and Australia Export vehicles.

This PI has been revised to add the Volt and update the Recommendation/Instructions. Please discard PI1299.

Condition/Concern

Some customers may comment that there is water present on the front passenger floor.

This condition may be caused by the air conditioning evaporator and blower module drain hose not being fully seated or has become disconnected or improperly installed during assembly.

Recommendation/Instructions

To correct this water leak:

- 1. Remove the front passenger carpet. Refer to the Front Floor Panel Carpet Replacement Right Side in SI.
 - If you observe puddles of liquid on the carpet face or in the vehicle, use a wet vacuum to remove the excess moisture.
 - Blot the face of the carpet with a towel in order to absorb as much moisture as possible and use a towel to dry the floor of the vehicle.
 - Point a fan at the affected area and air dry the carpet. Refer to Floor Carpet Drying in SI.


Note: Deodorize the interior or carpet if necessary.

2. Remove the right front floor console extension panel. Refer to Front Floor Console Extension Panel Replacement - Right Side in SI.




Note: Shown in the illustration above is where the plant temporary installs the A/C hose during Instrument panel installment. Do not drill out the

temporary holder for any reason.



Note: Shown in the illustration above is the A/C hose properly installed onto the correct drain port.



- **3.** Fully seat or reinstall the A/C drain hose (1).
- 4. Reinstall the right front floor console extension panel. Refer to Front Floor Console Extension Panel Replacement Right Side in SI.
- 5. Reinstall the front passenger carpet. Refer to the Front Floor Panel Carpet Replacement Right Side in SI.
