

**Making Sure Rear Underbody Cover is Installed Before Setting the Vehicle Down on its Wheels (66/15)**

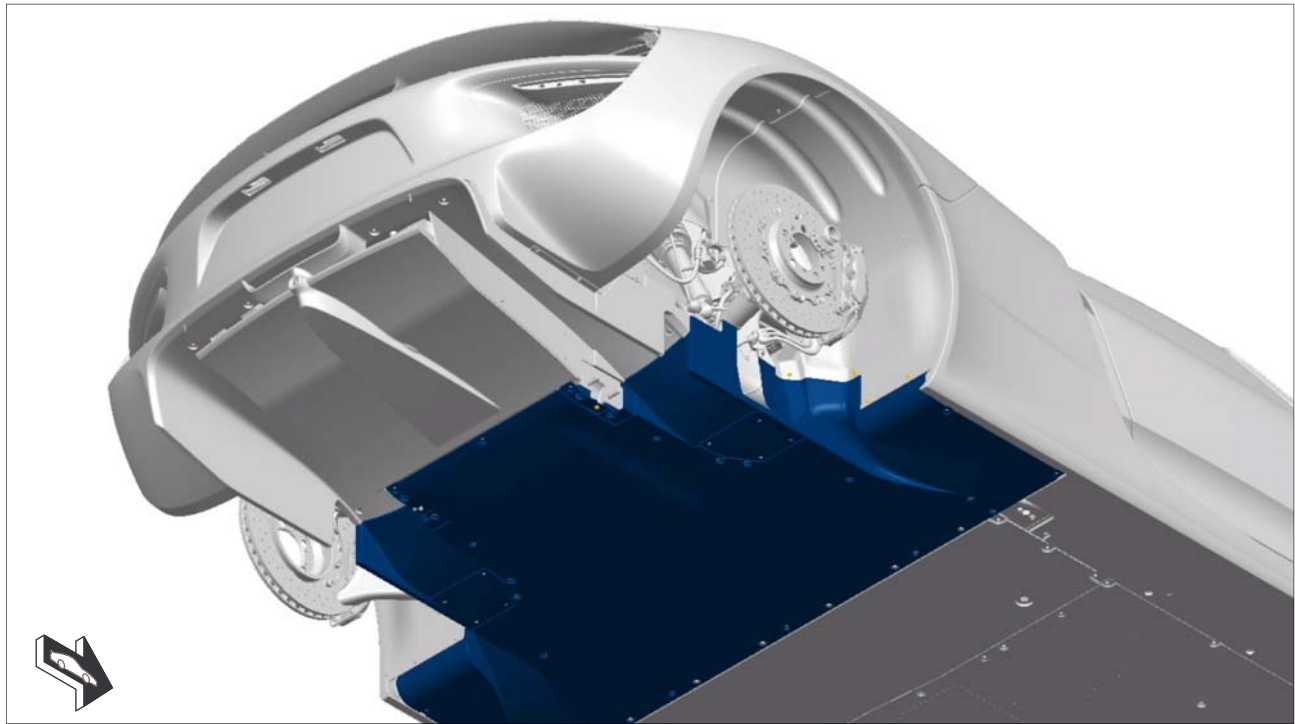
Concerns: **Rear underbody cover**

Information: **Make sure the rear underbody cover is installed** (see ⇒ *Installation position of rear underbody panelling*) **before setting the vehicle down on its wheels.**

If the rear underbody cover is removed:

- **The rear wheels must not be fitted** and
- The vehicle **must not be removed from the lifting platform.**

⇒ The fastening screws for the rear underbody cover secure important components and **help to improve the overall rigidity of the vehicle**, see also ⇒ *Workshop Manual '519419 Removing and installing cover for rear underbody'*.
