### Service

- 1. Verify the complaint.
- 2. If the vehicle is within the New Vehicle Limited Warranty, complete the attached brake acoustic questionnaire.
- 3. If the complaint is noise-related, obtain a sound or video recording (a cell phone recording is acceptable as long as the noise can be clearly identified).
- 4. Attach the completed questionnaire and sound or video recording to the TAC ticket. A sound recording is necessary to help determine the root cause of the noise and to help resolve the concern. If you are not able to attach these documents to the TAC ticket, email them to **chassis@audi.com** and notify TAC.
- 5. Contact a TAC consultant before proceeding with any repairs.
