In the event that an electric vehicle is taken to a **non**-high-voltage (HV) certified Audi dealership for service the vehicle must be clearly identified as an HV vehicle.

Also in the event that an HV expert is dispatched to your dealership to disable a HV vehicle electrical system due to a collision or other reason, the HV system must be properly disabled and clearly marked to ensure safety.

Starting September 23, 2015, every Audi dealer will be shipped one AT-379 Audi non e-tron Special Tool Package, Freight F.O.B. Snap-On OEM and invoiced directly by the Audi Special Tools Program (Snap-On Business Solutions - SBS).
