

#### Correction

If you encounter a vehicle with the above concern, complete the following procedure:

- 1. Raise the vehicle and visually inspect the fuel tank filler vent hose connector for damage. Refer to Lifting and Jacking the Vehicle in SI.
  - If connector is damaged, replace the fuel tank filler vent hose. Refer to Fuel Tank Filler Vent Hose Replacement in SI.
  - If there is no damage to the connector, continue diagnosis referring to SI.
