REVISION SUMMARY

Under WARRANTY CLAIM INFORMATION, the layout was clarified for L4 and V6 vehicles.

SYMPTOM

When a vehicle passes behind the 2015 TLX, The Cross-Traffic Monitoring (CTM) alert does not sound. The display screen shows CTM indicators (orange arrows) only.

POSSIBLE CAUSE

The current Combination Meter Unit software does not enable the audible alert for CTM.

CORRECTIVE ACTION

Update the Combination Meter unit software.

SOFTWARE INFORMATION

NOTE: Unnecessary or incorrect repairs resulting from a failure to update the HDS or MVCI are not covered under warranty.

REPAIR PROCEDURE

1. Update the combination meter unit software with the MVCI. Refer to Service Bulletin 01-026, *Updating Control Units/Modules*.

NOTE: The update cannot be done if the HDS is connected to the MVCI.

- 2. Connect the HDS to clear any DTCs.
- 3. V6 models only: Reset the PCM using the HDS, then do the idle learn procedure according to the electronic service manual.
