THE WITECH SOFTWARE IS REQUIRED TO BE AT THE LATEST RELEASE BEFORE PERFORMING THIS PROCEDURE.

#### SUBJECT:

Flash: Various Driveability Improvements

#### **OVERVIEW:**

This bulletin involves selectively erasing and reprogramming the Powertrain Control Module (PCM) with new software.

### **MODELS:**

2014 (PF) Dodge Dart

NOTE: This bulletin applies to vehicles \*\*equipped with a 2.0L engine (sales code ECK)\*\*.

### SYMPTOM/CONDITION:

\*\*Some customers may experience the EVIC Fuel Economy display is inaccurate or the Malfunction Indicator Lamp (MIL) illumination. Upon further investigation a technician may find one of more of the following Diagnostic Trouble Codes (DTCs) set in the PCM memory:

- U0140 Lost Communication With Body Control Module.
- P1D73 AGS Performance.
- P0116 Engine Coolant Temperature Sensor 1 Performance.
- P0456 Evap System Small Leak.\*\*

In addition to addressing the above DTCs, the following powertrain system improvements/enhancements are also included in this software release.

- Improved Enhanced Automatic Oil Change Indicator(EAOCI) system accuracy
- Corrected a generic scan tool display issue regarding Mode 6 data accuracy

### **DIAGNOSIS:**

Using a Scan Tool (wiTECH) with the appropriate Diagnostic Procedures available in TechCONNECT, verify all engine systems are functioning as designed. If DTCs are present record them on the repair order and repair as necessary before proceeding further with this bulletin.

If the customer describes the symptom/condition listed above or if the technician finds the DTCs, perform the Repair Procedure.

### REPAIR PROCEDURE:

NOTE: Install a battery charger to ensure battery voltage does not drop below 13.2 volts. Do not allow the charging voltage to climb above 13.5 volts during the flash process.

NOTE: If this flash process is interrupted/aborted, the flash should be restarted.

Reprogram the PCM with the latest software. Detailed instructions for flashing control
modules using the wiTECH Diagnostic Application are available by selecting the
"HELP" tab on the upper portion of the wiTECH window, then "HELP CONTENTS."
This will open the Welcome to wiTECH Help screen where help topics can be
selected.

# NOTE: After PCM reprogramming, the following must be performed.

Clear any DTCs that may have been set in other modules due to reprogramming. The wiTECH application will automatically present all DTCs after the flash and allow them to be cleared.

# **FAILURE CODE:**

The dealer must choose which failure code to use. If the customer came in with an issue and if the dealer finds a software update to correct that issue, use failure code CC, for all other use failure code RF.

- If the customer's concern matches the SYMPTOM/CONDITION identified in the Service Bulletin, failure code CC is to be used.
- If an available flash is completed while addressing a different customer concern, failure code RF is to be used.
