### INTRODUCTION

If you receive a customer concern of the EPS warning light coming on and diagnostics show a DTC C2532 stored in memory, a new EPS control unit is now available to address this code. There may also be a customer concern of increased steering effort along with the EPS warning light coming on.

### COUNTERMEASURE IN PRODUCTION

The new EPS control module was incorporated into production during November, 2013 starting with the following VINs:
