

INTRODUCTION

ATTENTION:

This bulletin announces a design change to the fuel filler door (saucer) assembly to address customer concerns of it being difficult to open and / or close. The striker portion's shape has been changed as shown in the crosssection illustration below along with the type of plastic material used in the construction of the saucer assembly.

IMPORTANT: This bulletin replaces TSB 09-58-14R dated 9/26/14 and 09-60-15R dated 10/26/15.



PRODUCTION CHANGE INFORMATION:

The new saucer assembly was incorporated into production during August, 2015 starting with the following VINs: Legacy: G*005915 and Outback: G*208318.
