#### Situation

Ducati's Quality Department has reviewed claims concerning possible detachment of the rider seat cover on the rear side; and a modified seat has been developed. We have decided to carry out the precautionary replacement of rider seats installed on the above-mentioned motorcycles, in order to prevent the occurrence of the defect.

On all the involved motorcycles it is thus necessary to inspect the batch number indicated at the bottom of the rider seat and, if previous to batch 16.2015, the seat *must* be replaced.

All the seats manufactured from Week 16-2015 included and forward are conforming; therefore they **must NOT** be replaced since they are already equipped with the technical update.

This Workshop Campaign *applies ONLY to original equipment seats*; therefore the seats sold as Ducati Performance accessories are not included.

#### Involved Bikes

The procedure described above has been coded as CR120, and you can find the precise list of VIN numbers involved in this campaign on DCS, in sections:

You can consult the single frame number.

You can consult all the VIN numbers that Ducati Motor Holding sent you.

#### Service Solution


Inspect the seat production batch, indicated in the sticker on the seat bottom.

If the seat batch code is higher than 16.2015 (batch 16.2015 included), the seat must **NOT** be replaced; if the seat batch code is lower than 16.2015, the seat **must be replaced** (the first number indicates the week, while the second number indicates the year).

### Warranty

Update procedure reimbursement will be issued through the standard warranty claim procedure via the section *Recall Campaigns* or *Vehicle History* of the DCS.

The procedure described above has been coded as *CR120*.

The Warranty Claim is pre-filled, and 3 types of repair are available, described in the table.

Warranty Claims filled-out in a way differing from the three types of repair described in the table may be subject to charge-back during periodic Ducati Warranty Parts Reconciliations.


Please find below an example to submit the new type of pre-filled multi-repair warranty claim:

1) Insert VIN in Vehicle History, if it is included in the list of serial numbers involved in CR120, the specific line will be displayed. Then select Apply:

2) A specific window to select the type of repair carried out on the bike will open; then select Repair Type 1, Repair Type 2 or Repair Type 3:

3) If Repair Type 1 - Only check of component part no. is selected, the request for a refund under warranty is automatically pre-filled as indicated in the table:
