DESCRIPTION:

This Campaign is being issued to address certain ISL CM2250 engines in transit bus applications experiencing frequent after-treatment regeneration issues. This field action authorizes certified repair locations to pro-actively recalibrate the electronic control module (ECM).

ACTION:

In order to qualify for repair under this field action, an engine:

- 1 will be covered Regardless of coverage status, and
- 2 must show an OPEN status for this field action on QuickServe® Online, and
- 3 must be in a transit bus application.

After verifying that the engine meets the above requirements, perform the following actions:

- 1 All engines will require an ECM calibration. To obtain a calibration via QuickServe Online (QSOL), enter the Engine Serial Number into QSOL, click on the "Service" tab, then "Related Information", then click on "Calibration Downloads" link and enter the requested information to obtain a Zip file to recalibrate the ECM.
- 2 Recalibrate the ECM as described in Procedure 019-032 in the appropriate Service Manual on QSOL. Provide documentation of ECM revision codes from before and after the recalibration in the claims section.
