- Subject: Engineering Information Check Engine Light Illuminated and DTC P0751 Set on Vehicles Under 5,000 Miles
- Attention: Proceed with this EI ONLY if the customer has commented about this concern AND the PIE number is listed in the Global Warranty Management / Investigate History link (GWM/IVH). If the customer has not commented about this condition or the EI does not show in GWM/IVH, disregard the PI and proceed with diagnostics found in published service information. THIS IS NOT A RECALL refer to the latest version of Service Bulletin 04-00-89-053 for more details on the use of Engineering Information bulletins.

Condition	Important: If the customer did not bring their vehicle in for this concern, DO NOT proceed with this EI. Some customers may comment on a check engine light illuminated. During diagnosis a technician may find DTC P0751 set.
Cause	GM Engineering is attempting to determine the root cause of the above condition. Engineering has a need to gather information on vehicles PRIOR to repair that may exhibit this condition. As a result, this information wil be used to "root cause" the customer's concern and develop/validate a field fix.

Correction

If you encounter a vehicle with the above concern and has less then 5,000 miles (8,000 km) with no magnetic debris is found in the bottom of the fluid pan, contact one of the engineers below before attempting any repairs.

Note: The engineer may request the control solenoid valve and transmission control module assembly returned undisturbed.
