Certain D-ring seat belt anchorage points may not have adequate reinforcement. In the event of a crash, the seat belt may not perform as expected and thereby increase the risk of injury.

This is the first of two notices you will receive regarding this subject. This letter is to inform you of an upcoming Recall to correct the issue noted above. Daimler Trucks is currently validating the repair and securing replacement parts. There is no action for you to take at this time.
