## SUBJECT:

Transmission Torque Converter Replacement Due To Dislodged Snap Ring

### **OVERVIEW:**

This bulletin involves replacing the torque converter after verifying that an internal snap ring has dislodged.

### **MODELS:**

2016	(D2)	Ram 3500 Pickup
2016	(DD)	Ram 3500 Cab Chassis
2016	(DP)	Ram 4500/5500 Cab Chassis

NOTE: This bulletin applies to vehicles within the following markets/countries: NAFTA.

NOTE: This bulletin applies to vehicles built on or after March 29, 2016 (MDH 0329XX) and on or before April 11, 2016 (MDH 0411XX) equipped with a 6.7L I6 Cummins Turbo Diesel Engine (Sales Code ETK) and 6-SPD Auto Aisin AS69RC HD Trans (Sales Code DF2).

#### SYMPTOM/CONDITION:

A small number of customers may experience a Malfunction Indicator Lamp (MIL) illumination. Upon further investigation the technician may find the following Diagnostic Trouble Code (DTC) set in the Transmission Control Module (TCM) memory:

• P2757-00 - TCC Pressure Control Solenoid Control Circuit Performance.

## **DIAGNOSIS:**

Using a Scan Tool (wiTECH) with the appropriate Diagnostic Procedures available in TechCONNECT, verify all related systems are functioning as designed. If DTCs or symptom conditions, other than the ones listed above are present, record the issues on the repair order and repair as necessary before proceeding further with this bulletin.

If a customer's VIN is listed in VIP or your RRT VIN list, perform the repair.

NOTE: \*\*If the VIN is on the RRT VIN List no diagnosis is required, replace the torque converter per the Repair Procedure.\*\*
