Vehicles may contain one or more incorrect labels.


CAUSE

Incorrect labels attached during production.

CORRECTION

Replace compliance label and additional labels if necessary.

PROCEDURE

	<ol style="list-style-type: none"> 1. Examine the compliance label on the B-pillar.
	<ol style="list-style-type: none"> 2. Does the chassis number agree with the



vehicle documentation?

YES- nothing further is required. Vehicle is in compliance.

NO – compliance label and other listed labels must be replaced. Refer to chart below to determine which labels to be replaced. Order only those labels which are indicated in the chart.

Go to Step 3.

3. Remove the compliance label and additional labels according to chart below; heat prior to removing if needed.
4. Clean any residual adhesive after label removal.
5. Attach new labels in their respective locations.
