#### SUBJECT:

Engine Stall Immediately Following Fuel Tank Fill-Up (X60 Warranty Extension)

# OVERVIEW:

This bulletin involves replacing the fuel tank and vapor canister.

# MODELS:

2004 - 2005 (RS)

Dodge Caravan Chrysler Town and Country

NOTE: This bulletin applies to vehicles within the following markets/countries: NAFTA, EMEA or APAC.

# NOTE: This bulletin applies to vehicles built on or after September 01, 2003 (MDH 0901XX) and built on or before March 31, 2004 (MDH 0331XX).

#### SYMPTOM/CONDITION:

Some customers may experience an engine stumble or stall condition which occurs immediately after filling the fuel tank. The integral multi-functional control valve may stick allowing liquid fuel to enter the evaporative emissions system causing a rich fuel condition when the purge system is initiated.

Using a Scan Tool (wiTECH) with the appropriate Diagnostic Procedures available in TechCONNECT, verify all engine systems are functioning as designed. If Diagnostic Trouble Codes (DTCs) or symptom conditions, other than the ones listed above are present, record the issues on the repair order and repair as necessary before proceeding further with this bulletin.

If the customer describes the symptom/condition listed above, perform the Repair Procedure.

# PARTS REQUIRED:

#### REPAIR PROCEDURE:

 Replace the fuel tank. Refer to the detailed removal and installation procedure available in DealerCONNECT> Service> TechCONNECT> Service Info> 14 - Fuel System> Fuel Delivery> Fuel Tank> Removal/Installation.

# NOTE: 2005 MY vehicles have a choice of repair procedures, with or without Fold in Floor (Stow and Go) seating. Select the correct procedure per the vehicle application.

- 2. Replace the Vapor Canister. Refer to the detailed removal and installation procedure available in DealerCONNECT> Service> TechCONNECT> Service Info> 25 Emission Control> Evaporative Emissions> Vapor Canister> Removal/Installation.
- 3. Clear any DTCs that may have been set for this condition.

# POLICY:

Reimbursable within the provisions of the warranty.
