SUBJECT:

Incorrect Front License Plate Bracket

OVERVIEW:

This bulletin involves inspecting and if necessary, replacing the front license plate bracket.

MODELS:

2017 (RU) Chrysler Pacifica

NOTE: This bulletin applies to vehicles within the following markets/countries: NAFTA.

NOTE: This bulletin applies to vehicles built on or before April 20, 2016 (MDH 0420XX) equipped with Painted Front Fascia W/Mic Black Accent (Sales Codes MLF).

SYMPTOM/CONDITION:

The vehicle may have the incorrect front license plate bracket in the vehicle.

The vehicle may have a been shipped with a license plate bracket kit for a high line fascia that will not fit vehicles with a base line fascia.

DIAGNOSIS:

If a customer's VIN is listed in VIP or your RRT VIN list, perform the repair. For all other customers that describe the symptom/condition listed above, perform the Repair Procedure.

PARTS REQUIRED:

1	**68259460AA**	Front License Plate Kit (Base Fascia)

REPAIR PROCEDURE:

- 1. If the vehicle has a (Sales Code of MLF) and the part number for the license plate kit in the vehicle is for a high line front fascia, the bracket will need to be replaced.
- 2. Is the front license plate kit for high line front fascia vehicle?
 - a. YES>>> Replace the front license plate kit as required. Proceed to Step #3.
 - b. NO>>> The front license plate kit is for a baseline front fascia vehicle which is correct. This bulletin has been completed. Use LOP (13-05-01-93) to close the active RRT.
- 3. Install the front license plate bracket kit to the vehicle if the state that the vehicle is registered in requires a front license plate. Refer to the detailed service procedures available in DealerCONNECT> TechCONNECT under: Service Info>04 Vehicle Quick Reference/New Vehicle Preparation Instructions/Standard Procedure>Standard Procedure New Vehicle Preparation>Vehicle Readiness>Install Front License Plate Bracket (if required).

NOTE: If the vehicle is registered in a state that does not require a front license plate then place the bracket inside the vehicle for the customer.
