#### Subject: Rear Door Handle Will Not Open the Door, Child Safety Lock Sticking



Condition	Some customers may comment that the rear door handle will not open the door.		
Cause	<ul> <li>This may be caused by the following conditions:</li> <li>Child lock mechanism stuck in either positions.</li> <li>Inside door handle lock cables not seated properly.</li> <li>Outside door handle lock cables not seated properly.</li> <li>Latch cable abutment not seated properly.</li> </ul>		

#### Correction

If the rear door handles will not open the doors due to the Child Safety Latch switch stuck, **Do Not** replace the door latches until the following procedure has been completed. The handle cables must be inspected for proper installation into the inside door handle to latch end, the outside door handle to latch end and the cable abutment sleeves mounted into their respective mounts.


### **Service Procedure**



1. Using care, remove the door trim panel.

- 2. Inspect the inside door handle cable tension (3) and abutment (2) for improper installation onto the mount (1) as shown on the left.
- 3. Validate the cables anchor (6) is inserted into the latch throw (4) and the abutment is locked onto the mount (5) as shown on the right.




**Note:** It may be required to remove the door latch and handle assembly from the door to properly inspect the handle cables to the latch ends.

- Inspect the inside door handle cable locking pin (1), cable tension and abutment (2) for improper installation into the latch as shown on the left.
- 5. Validate the cables locking pin is inserted into the latch throw (3) and the abutment (4) is locked in the mount as shown on the right.

- 6. Inspect the outside door handle cable anchor (1) and abutment (2) for improper installation into the latch as shown on the left.
- 7. Validate the abutment is locked into the mount (4) and the cable anchor is secured into the latch (3) as shown on the right.

- 8. Inspect the outside door handle cable tension (1) and abutment (2) for improper installation into the handle as shown on the left.
- 9. Validate the abutment (3) is locked into the mount (4) as shown on the right.
- 10. Validate the cables are in working condition, free of kinks, fraying, and properly installed in the mounts.
  - ⇒ If the cables are kinked, frayed or not properly installed in the mounts, correct as needed.
- 11. Validate proper Child Lock operation in the ON and OFF positions from inside and outside of vehicle.

If there are no inside or outside handle cable connection issues, refer to SI.
