**INTRODUCTION:**

This Service Information bulletin announces a production method change to the rear combination lamp assembly. The application procedure of the anti-fog coating was changed to prevent a customer concern of visible drip marks (or streaks) appearing on the inside of the lamp lens.

**PRODUCTION CHANGE INFORMATION:**

The new rear combination lamps were incorporated into production starting with VIN **H\*207607**.
