# **DESCRIPTION**

APPLICABLE MODEL(S)/VINS

2007-2015 CX-9 vehicles with VINs lower than JM3TB\*\*\*\*\*470223 (produced before November 18, 2015)

Some vehicles may experience a knocking noise from the front shock absorbers when driving over rough roads or speed bumps. The noise may be caused by damage to the inner seal of front shock absorber, resulting in fluid seepage. To eliminate this concern, modified parts with improved oil sealing performance have been established as service parts.

Customers having this concern should have their vehicle repaired using the following repair procedure.

#### REPAIR PROCEDURE

- 1. Verify the customer complaint.
- 2. If the knocking noise is confirmed to be coming from the front shock absorbers when driving over rough roads or speed bumps, replace both front shock absorbers with the modified ones according to the instructions on MGSS online (FRONT SHOCK ABSORBER AND COIL SPRING REMOVAL/INSTALLATION).
- 3. Verify repair.
