## TECHNICAL SERVICE BULLETIN Tire/Wheel Vibration At Highway Speeds Above 80 Km/h (50 MPH)

This bulletin supersedes 16-0142. Reason for update: Concern Carryover to New Model

Ford 2017-2018 Escape

#### Summary

This article supersedes TSB 16-0142 to update the vehicle model years.

**Issue:** Some 2017-2018 Escape vehicles may exhibit a vibration at highway speeds above 80 Km/h (50 MPH) which may be attributed to short term flat spotting in the tires.

Action: Follow the Service Procedure steps to correct the condition.

**Warranty Status:** Eligible Under Provisions Of New Vehicle Limited Warranty Coverage Warranty/ESP coverage limits/policies/prior approvals are not altered by a TSB. Warranty/ESP coverage limits are determined by the identified causal part and verified using the OASIS part coverage tool.

## **Service Procedure**

- 1. Visually inspect the tires for possible damage. Are any concerns present?
  - (1). Yes this article does not apply. Refer to Workshop Manual (WSM), Section 204-04.
  - (2). No proceed to Step 2.
- 2. Check and adjust tire pressures to placard specification.
- **3.** Drive the vehicle to confirm customer concern. The vehicle must be driven a minimum of 15 miles to eliminate any temporary flat spotting conditions. Is the vibration still present?
  - (1). Yes this article does not apply. Refer to WSM, Section 204-04.
  - (2). No no further action required. Return the vehicle to the customer.
