

- 3. Verify the power brake booster vacuum pipe is NOT contacting the brake lines and is routed properly.
 - If the power brake booster vacuum pipe is NOT contacting the brake lines and is routed properly, no further action is required.
 - If the power brake booster vacuum pipe is contacting the brake lines or is NOT routed properly, inspect the power brake booster vacuum pipe for damage.
 - If the power brake booster vacuum pipe is NOT damaged, proceed to the next step.
 - If the power brake booster vacuum pipe is damaged, replace the power brake booster vacuum pipe and proceed to the next step. Refer to *Power Brake Booster Vacuum Pipe Replacement* (LYX) in SI.

- 4. Route the power brake booster vacuum pipe as shown above. The power brake booster vacuum sensor electrical connector (1) MUST be horizontal and the vacuum pipe pointing away from the master cylinder for it to be properly routed.
- 5. Remove fender covers and close hood.
