- · ABS light is illuminated
- Safety Recall 45F5 shows closed in Elsa

One or both of the following DTCs is stored in the ABS control module, J104 (address word 0003):

- DTC 01130 (ABS operation implausible signal), with 125 shown in the 4th line of the expanded ambient conditions
- DTC 16352 (control module faulty), with 96 shown in the 4th line of the expanded ambient conditions

Technical Background

An insufficient PCU ground connection in the ABS control module could cause the module to fail during ABS and/or electronic stability control (ESC) activation. Safety Recall 45F5 updated the ABS control module software with improved diagnostic capability to detect these faults.

Production Solution

Not applicable.
