SUBJECT:

Flash: Transmission Shift and Driveability Enhancements

OVERVIEW:

This bulletin involves reprogramming the Transmission Control Module (TCM) with the latest available software.

MODELS:

2015 - 2016

RAM ProMaster City

NOTE: This bulletin applies to vehicles equipped with a 2.4L Engine (Sales Code ED6) and a 9-SPD 948TE FWD Automatic Transmission (Sales Code DFH).

SYMPTOM/CONDITION:

Customers may experience a Malfunction Indicator Lamp (MIL) illumination. Upon further investigation the technician may find one or more of the following Diagnostic Trouble Codes (DTCs):

- P0887 TCM Power Control Circuit High.
- P1720 Output Speed Sensor-Wheel Speed Rationality.

(VM)

- P1634 Output Speed Sensor-Wheel Speed Rationality.
- P1DCCD TCM Monitoring Processor Performance Multiple Clutches Locked Up.
- P0711 Transmission Fluid Temperature Sensor A Circuit Range-Performance.
- P1DAD Input Shaft-Output Shaft Direction Correlation.
- P1CC9 Unable To Engage Gear.

In addition the following enhancements are included:

- **Calibrations to support changes in air flow to protect the catalyst.**
- Transmission shift quality.
- Enable the capability to capture non-DTC control module data through the Uconnect data recording system.

DIAGNOSIS:

Using a Scan Tool (wiTECH) with the appropriate Diagnostic Procedures available in TechCONNECT, verify all related systems are functioning as designed. If DTCs or symptom conditions, other than the ones listed above are present, record the issues on the repair order and repair as necessary before proceeding further with this bulletin.

If the customer describes the symptom/condition listed above or if the technician finds the DTC, perform the Repair Procedure.

REPAIR PROCEDURE:

- NOTE: The Powertrain Control Module (PCM) MUST be updated to the latest available software. Refer to all applicable published service bulletins for detailed repair procedures and labor times regarding updating the PCM software.
- NOTE: Install a battery charger to ensure battery voltage does not drop below 13.2 volts. Do not allow the charging voltage to climb above 13.5 volts during the flash process.

NOTE: If this flash process is interrupted/aborted, the flash should be restarted.

- 1. Reprogram the TCM with the latest software. Detailed instructions for flashing control modules using the wiTECH Diagnostic Application are available by selecting the application's "HELP" tab.
- 2. Clear all DTCs that may have been set in any module due to reprogramming. The wiTECH application will automatically present all DTCs after the flash and allow them to be cleared.

NOTE: Do not clear the shift adaptives in the TCM's memory. this action may cause the transmission to not shift smoothly until the adaptives are re-learned.

POLICY:

Reimbursable within the provisions of the warranty.

NOTE: The expected completion time for the flash download portion of this procedure is approximately 4 minutes. Actual flash download times may be affected by vehicle connection and network capabilities.

FAILURE CODE:

The dealer must use failure code CC with this Service Bulletin.

- If the customer's concern matches the SYMPTOM/CONDITION identified in the Service Bulletin, failure code CC is to be used.
- When utilizing this failure code, the 3C's (customer's concern, cause and correction) must be provided for processing Service Bulletin flash/reprogramming conditions.
