



 Remove the front upper fascia (1). Refer to Front Bumper Upper Fascia Replacement (Equinox) in SI.



2. Remove the rear bumper upper fascia (1). Refer to Rear Bumper Upper Fascia Replacement (Equinox) in SI.



- 3. Color/clear coat the front upper fascia.
- 4. To insure color match to the front fascia, partial color/clear coat both front fenders.
- 5. Color/clear coat the rear upper fascia.

6. Remove the right and left rear body structure stop lamps. Refer to Rear Body Structure Stop Lamp Replacement in SI.

7. Remove the right and left quarter windows. Refer to *Body Side Window Replacement* in SI.



- Reinstall the right and left rear body structure stop lamps. Refer to Rear Body Structure Stop Lamp Replacement in SI.
- 13. Reinstall the rear bumper upper fascia. Refer to Rear Bumper Upper Fascia Replacement (Equinox) in SI.
- 14. Reinstall the front upper fascia. Refer to Front Bumper Upper Fascia Replacement (Equinox) in SI

#### **Parts Information**

Replace liftgate emblems as necessary. Use the vehicle identification number (VIN), SI, and the GM Electronic Parts Catalog to determine the proper parts to order.

- 8. Remove the liftgate trim panels. Refer to *Liftgate Upper Side Trim Finish Panel Replacement,* in SI.
- 9. To insure color match to rear fascia, partial color/clear coat both quarter panels and the liftgate.
- 10. Reinstall the liftgate trim panels. Refer to Liftgate Upper Side Trim Finish Panel Replacement, in SI.
- 11. Reinstall the right and left quarter windows. Refer to *Body Side Window Replacement* in SI.
