



Condition	Some customers may comment on an exhaust fume odor or smell in the vehicle cabin.
Cause	
	The cause of the condition may be that the original torque specification noted for the underhood dash panel upper extension panel (1) installation, was too high.
	This over-torque may lead to cracking the plastic panel or creating a buckling and too large of a gap between the extension panel and the plenum.
Correction	Verify the condition and inspect the underhood dash panel upper extension panel following the steps in the Service Procedure below.

Service Procedure

- 1. Remove the air inlet grille panel (1). Refer to *Air Inlet Grille Panel Replacement* in SI.
- Visually inspect the underhood dash panel upper extension panel for cracks at the fastener locations. Also, between the fastener locations, check for buckles/gaps of over 2 mm between the extension panel and plenum.

Important: The torque specification currently published in SI is INCORRECT, and is in the process of being updated. The dash panel upper extension panel attachment bolts should be tightened to a torque of 4.5 N·m (40 lb in).

- If the extension panel exhibits any damage or gaps, replace the panel (1). Refer to Dash Panel Upper Extension Panel Extension Replacement in SI.
- If no damage/gapping is found, reinstall the air inlet grille panel and refer to SI for further recommended diagnostics.
