INFORMATION FOR INSTALLATION OF A CHILD RESTRAINT SYSTEM AND

CORRECTION TO THE TIRE AND LOADING INFORMATION LABEL)

Toyota will conduct a Special Service Campaign to provide involved vehicle owners with an updated Owner's Manual and a supplemental label regarding the installation of a Child Restraint System (CRS) in the rear auxiliary seat of the vehicle. The updated Owner's Manual and supplemental label is meant to better inform the owners of the correct CRS installation procedure, which includes flipping the rear auxiliary seat cushion forward.

The right rear auxiliary seat is also equipped with a child restraint anchorage system that is designed to be used with certain CRSs manufactured after 2002 which contain specialized attachment hardware. Older CRSs, as well as all booster seats, may be installed at either the left or right rear position using the vehicle's safety belts.

In addition, for specific late 2005 through late 2006 model year Tacoma vehicles which have a Tire and Loading Information Label that does not reflect the presence of the two auxiliary seats in the rear of the cabin, a new label will be mailed to the owners.

The following vital information is provided to inform you and your staff of the activity schedule and your degree of involvement.

## 1. Owner Notification Mailing Date

The owner notification will commence in late August, 2006.

Owner notifications will contain the updated Owner's Manual and applicable label(s). The owners will be requested to install these items on their vehicle. We request the assistance of Toyota dealerships if customers have any questions or request assistance in affixing the label(s).

Please note that only owners of the affected vehicles will be notified.

## 2. Number and Identification of Involved Vehicles

There are approximately 114,000 2005 through late 2006 Model Year Tacoma vehicles involved in the U.S.

## 3. Vehicles in Dealer Stock

Dealers are requested to replace the Owner's Manual and affix the applicable label(s) to any vehicle in their inventory prior to customer delivery. As vehicles are also being updated at NUMMI, please verify **eligibility by confirming through Dealer Daily/TIS prior to performing this SSC**. Dealers should perform the campaign work as outlined in the attached Technical Instructions.

## 4. Dealer/Owner Lists

As the updated Owner's Manual and applicable label(s) will be mailed directly to the vehicle owner, Dealer/Owner Lists will not be included for this SSC.

## 5. Parts Ordering

Owners of the specific 2005 through late 2006 model year Tacoma Access Cab vehicles had the updated Owner's Manual and applicable label(s) mailed directly to them.

If the updated Owner's Manual and applicable labels are not installed, they can be ordered through either NAPO or MDC as follows:



As part of our continuing efforts to provide superior customer satisfaction, Toyota is announcing a Special Service Campaign Program on certain 2005 to late 2006 model year Tacoma Access Cab vehicles to clarify as well as provide supplemental information on how to install a Child Restraint System ("CRS") in the rear area of the vehicle cabin. In addition, Toyota would like to correct an error that may exist on your vehicle's Tire and Loading Information Label ("tire label").

#### What is the condition?

Your Tacoma Access Cab vehicle has been designed to maximize your cargo carrying capacity, yet afford a limited ability to carry additional passengers. To accomplish this task, the rear area of the cabin has been uniquely designed with two flip-over auxiliary seats. When installing a CRS in the rear of your vehicle, to assure appropriate stability, please flip over the bottom cushion of the auxiliary seat to create the cargo panel configuration and install the CRS on the resulting surface.

In addition to these concerns, due to a labeling error the "seating capacity" specified on your vehicle's tire label may not reflect the two auxiliary seats in the rear of the vehicle. To correct this error, Toyota is enclosing a new tire label, which correctly reflects the vehicle's seating capacity (Total 4, Front 2, and Rear 2). Please note that this change these seating capacity of your vehicle, as the combined weight of occupants and cargo should still never exceed the limit indicated on the label.

## What should you do?

Please assist us by taking the following actions:

- Replace your original Owner's Manual with the new one and dispose of the original manual to avoid confusion. The new Owner's Manual can be identified by an orange dot on the back cover.
- Affix the supplemental label that describes the proper way to install CRSs, in accordance with the
  enclosed instructions.
- Examine the tire label on your vehicle, which can be located using the enclosed instructions. If it
  currently indicates that the total seating capacity is 2, please, affix the new tire label over the original
  label following the instructions provided.

If you prefer, your local Toyota dealer will be more than happy to assist you in installing the labels into your vehicle at NO CHARGE. If you choose to have the Toyota dealer affix the new label, please present this notice and the enclosed labels to the dealer at the time of your appointment.




The new Tire and Loading Information Label includes only the section of information that has been updated, the remaining portions of the label are clear plastic.

 Affix the new Tire and Loading Information Label over the old label while smoothing out any air bubbles in the new label.

Special Service Campaign (SSC) 60E Q&A 2005 through late 2006 Model Year Tacoma Access Cab Child Restraint System & Tire and Loading Information Label

### Q1: What is the condition?

A1: Toyota will conduct a Special Service Campaign to provide involved vehicle owners with an updated Owner's Manual and a supplemental label regarding the installation of a Child Restraint System (CRS) in the rear auxiliary seats of the vehicle. The updated Owner's Manual and supplemental label sent to owners is meant to better inform the owners of the correct CRS installation procedure, which includes flipping the rear auxiliary seat cushion forward.

The right rear auxiliary seat is also equipped with a child restraint anchorage system that is designed to be used with certain CRSs manufactured after 2002 which contain specialized attachment hardware. Older CRSs, as well as all booster seats, may be installed at either the left or right rear position using the vehicle's safety belts.

In addition, for specific late 2005 through late 2006 model year Tacoma vehicles which have a Tire and Loading Information Label that does not reflect the presence of the two auxiliary seats in the rear of the cabin, a new label will be mailed to the owners.

## Q2: Which and how many vehicles are involved?

A2: There are approximately 114,000 2005 through late 2006 Model Year Tacoma Access cab vehicles involved in the U.S.

#### Q3: What is the production period of the affected vehicles?

A3: The affected Tacoma Access cab vehicles were produced from mid September 2004 to early June 2006.

# Q4: Are there any other Toyota. Lexus or Scion vehicles involved?

A4: No, this specific condition only affects certain 2005 through late 2006 model year Tacoma Access cab vehicles.

# Q5: How many incidents of this condition have been reported?

A5: There have been no cases of this condition reported in the affected vehicles.

## Q6: Have there been any accidents reported?

A6: There have been no reported cases of accidents in the affected vehicles which may relate to this condition.

#### Q7: Have there been any injuries related to the alleged accidents?

A7: There have been no reported cases of injuries related to this condition reported in the affected vehicles.

#### Q8: What is Tovota going to do?

A8: Owners of the involved vehicles will receive the updated Owner's Manual and the supplemental label regarding the installation of a Child Restraint System (CRS) by first class mail. In addition, for specific late 2005 through late 2006 model year Tacoma vehicles which have a Tire and Loading Information Label that does not reflect the presence of the two auxiliary seats in the rear of the cabin, an additional new label will be mailed to the owners. Owners will be requested to replace the Owner's Manual and affix the label(s). Toyota dealers will assist customers who prefer to have the dealer to perform the installation of the label(s) at NO CHARGE to the vehicle owners.

## Q9: How long will the repair take?

A9: Installing the label(s) will only require a few minutes. However, depending upon the dealer's work schedule, it may be necessary to make the vehicle available for a longer period of time.

# [For Toyota Dealers Only]

- Q10: Didn't Toyota launch a similar campaign on Tacoma Access Cab vehicles late last year changing the Tire Information Label from "Total 4 (Front 2, Rear 2)" to "Total 2 (Front 2, Rear 0)"?
- A10: Yes, Toyota launched SSC 50R in late October/early November 2005. However, since that time, it has been determined the *two rear auxiliary seating positions should be included* in the total number of seating positions, and therefore, SSC 50R has been removed from TIS and the updating of certain late 2005 through late 2006 model year Tacoma Access Cab vehicle's Tire Information Label has been incorporated into SSC 60E. This in effect reverses SSC 50R.
