This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Daimler Trucks North America LLC (DTNA), on behalf of its wholly owned subsidiary, Freightliner Customer Chassis Corporation, has decided that a defect which relates to motor vehicle safety exists on S2G chassis manufactured August 24, 2012, through April 10, 2017, and equipped with an LPG engine.

On certain vehicles an airline hose and heater wire may be improperly routed or secured near the engine exhaust which could cause melting or shorting of the lines. Melting or shorting of the lines may increase the risk of a fire.

This is the first of two notices you will receive regarding this subject. This letter is to inform you of an upcoming Recall to correct the issue noted above. Daimler Trucks is currently validating the repair and securing replacement parts. There is no action for you to take at this time.

The second notice will inform you when the final remedy is available. **When you receive the second notice**, please contact your authorized Daimler Trucks North America dealer to schedule the Recall for your vehicle.

If you do not own the vehicle that corresponds to the identification number(s) which appears on the Recall Notification, please return the notification to the Warranty Campaigns Department with any information you can furnish that will assist us in locating the present owner. If you have leased this vehicle, Federal law requires that you forward this notice to the lessee within 10 days. Objet : Acheminement d'une conduite d'air sur les châssis GPL S2G de FCCC

Cet avis vous a été envoyé conformément à la Loi sur la sécurité automobile du Canada.

Au nom de sa division de camions Freightliner Customer Chassis Corporation, Daimler Trucks North America LLC (DTNA), a déterminé qu'une défectuosité liée à la sécurité des véhicules automobiles existe sur certains châssis S2G fabriqués entre le 3 juillet 2014 et le 23 novembre 2016, équipés d'un moteur au propane liquide (GPL).

Sur certains véhicules, il peut arriver qu'une conduite d'air flexible et un câble de chauffage soient mal disposés ou soient fixés à proximité de l'échappement du moteur, ce qui pourrait entraîner leur fusion ou un court-circuit. Leur fusion ou un court-circuit augmente les risques d'incendie.

Ceci est le premier de deux avis que vous recevrez à ce sujet. Le but de cette lettre est de vous informer d'un rappel à venir pour corriger le problème mentionné ci-dessus. Daimler Trucks effectue actuellement la validation de la réparation et prépare la fourniture des pièces de rechange. Vous n'avez pas d'action à prendre pour l'instant.

Le deuxième avis vous informera quand le remède final sera disponible. **Lorsque vous recevez le deuxième avis**, veuillez contacter votre concessionnaire autorisé Daimler Trucks North America, afin de prendre les dispositions nécessaires pour le rappel de votre véhicule.

Si vous n'êtes pas le propriétaire du ou des véhicules dont les numéros d'identification apparaissent sur l'avis de rappel, veuillez retourner l'avis au Service des campagnes de garanties avec tous les renseignements dont vous disposez qui pourraient nous aider à identifier le propriétaire actuel. Le loueur est également tenu par la loi fédérale de faire parvenir cet avis au locataire dans les 10 jours.
