- Clean any residue using isopropyl alcohol and dry with clean, lint free cloth. Receiving surface MUST be clean, dry and free of any contaminants.
- 3. Firmly hold the new label and peel protective liner from the back side, being careful not to touch or contaminate the adhesive with dirt or foreign matter.

- 4. Carefully align new labels to the surface. Press firmly and smooth out entire label ensuring corners are fully adhered as shown above.
- 5. Close the fuel door.
