Front or Rear Door Arrester (Door Check Rod/Door Check Strap) Noisy or Defective

One or more of the following conditions are exhibited:

- Noise (grinding, popping, creaking, clicking, etc.) when opening or closing the door.
- Door binding during opening or closing operation.

Technical Background

The condition is caused by water ingress into the door arrester that accumulates in the arrester cover (boot) and freezes during cold weather conditions. The ice built up around the door arrester slider spring prevents it from compressing during door opening and closing operation and the spring will eventually wear through the plastic slider and damage the check rod.

Production Solution

From CW47/15 to CW50/16 the door arrester is mounted to the door using bolts that has a smaller diameter head. The smaller diameter bolt head provides the necessary clearance for the door arrester seal to properly seal against the door and prevent water entering the door arrester cover. As of CW50/16 the internal door sheet metal and bracket was modified to allow water drainage from the door arrester cover.

Service

Step 1. Replace affected door arrester (door check strap/door check rod), and drill water drain hole in door arrester cover (boot).

- Remove the affected door arrester with cover according to the repair manual.
- Replace the door arrester.
- Check the door arrester cover for damage:

If the arrester cover is damaged, it must be replaced according to the parts catalog. If the cover is undamaged, clean and reuse the part.



Drill a water drain hole in the door arrester cover:




Figure 3. Example of door arrester cover with water drain hole for left side of the vehicle ("R top")

Use a metal drill bit (diameter 8 mm) to drill a water drain hole (Figure 3.) in the door arrester cover as follows.

On the left side of the vehicle the hole must be drilled on the side of the cover where it says "R top" (Figure 4. red ellipse).

On the right side of the vehicle the hole must be drilled on the side of the cover where it says "L top".




Figure 5. Reference point of water drain hole

• Drill a water drain hole at a distance of 10 mm in the door arrester cover, measured from the crease in the cover as shown in figure 5.

Assemble the cover to the new door arrester in preparation for installation.



When the door arrester is installed in the door, the water drain hole must be pointing down towards the bottom of the door.



Step 2. Install the door arrester using bolts with smaller head dimension

 To install the new door arrester, discard the bolts – 2 (figure 6.) from the old door arrester and install the new door arrester using new bolt part number: N 107 732 01 (Figure 7).

Complete the installation per the instructions in Elsa.



The old part number bolts MUST be discarded and the new part number bolts MUST be used for the installation of the new door arrester.


